Program Guide

Requirements

Before conducting this program, you must read and apply all standards, procedures and requirements for this program and general DDI education as detailed in a current valid DDI Instructor Manual.

How to conduct the program

Before conducting any parts of this program, you must verify and record that the student is certified within a DDI recognized disabled diving certification agency.

1. Verification of certification can be done by obtaining a copy of front and back of a certification card or written acknowledgement of certification from the certifying agency.
2. Verification of certification agency's recognition by DDI may be obtained by contacting DDI for a current list of recognized agencies.

To conduct this program, use the requirements and program standards for the DDI professional certification that the student will cross-over to for content of knowledge, confined water and open water development that must be confirmed or trained. In contrast to conducting a normal DDI Pro-Training program, the DDI Pro-Training Cross-Over program allows for exemption of certain parts of the required training depending on the students current disabled diving certification.

Knowledge Development

- Review of Medical Information 1½ hour
- Open Water Workshop 1½ hour
- Review of DDI Standards 1½ hours
- Review of DDI websites and member databases ½ hour
- DDI Pro Training Examination ½ hour
- Evaluation and certification ½ hour

Confined Water Development

- Confined Water skill training 2½ hours
- Look for all the exercises in the Outline of Pro- training course.

Sign and submit a Safe Diving Practices Agreement, Pro member agreement, where applicable a liability waiver, and DDI Pro Training Record Form
